This arena is on the frontage road of Hwy 41 just 2 miles north of Riverdale. **From 99 North,** take Hwy 41 South (in Fresno) toward Lemoore. Drive about 30 minutes to Elkhorn Ave. turn left and an immediate right onto frontage road. Arena will be ½ mile on left. **From the South**, Hwy 198 connects I5 and Hwy99. Go North on Hwy41 from Lemoore or from Kettlemen city Exit 15. Continue North on Hwy41 past Riverdale to Harlan Ave. Turn Right and an immediate left onto frontage road. Arena is about 1 mile on right.

**CATTLE-** beef cross, 3 head, Course B/Sat- Course B/Sun **DUCKS-** Indian runners, 5 head, Course B both days

## TRIAL 8AM SAT & SUN PM TRIAL IMMEDIATELY FOLLOWING

(handlers meeting 20 minutes prior to each trial) Run order will be determined by random draw prior to trial

CLASSES: Advanced, Open, Started, Novice, Junior

Returned check invalidates entry and will be charged a \$25 fee.

All entries must be on official ASCA entry form. Trial will be run under ASCA rules & regs.

Non ASCA entries must be approved herding breeds and have an ASCA Tracking number in order to receive certification/titles. Forms available at trial. (See ASCA.org)

**PRE-ENTRY** will be accepted beginning postmark **JAN. 25, 2016.** Pre-entry closing must be **POSTMARKED** on or before **FEBRUARY 15, 2016.** Late entries and/or day of trial entries, if available, add \$10 per run.

Entries will not be refunded for any reason after the pre-entry closing date of Feb. 15, 2016

Exhibitors are responsible for any injuries to livestock. Replacement value will be posted at trial.

**Ducks** \$30/run **Sheep** \$40/run **Cattle** \$50/run

(\$120 per trial all 3 types of stock) IF ENTERING ALL 4 TRIALS/3 TYPES OF STOCK, REDUCE TO \$110 PER TRIAL

Bitches in Season may be run or be substituted but will run in order and must be crated when not competing.

High Combined Aussie, Most Promising Started Aussie & Additional awards for High Combined Other Breed, High Combined Cattle, Sheep, Ducks. You must enter all 3 types of livestock, in all 4 trials. NOTE: If only 1 dog is eligible for an award, it must have at least 9 scores.

**Awards for each trial:** High Score: Cattle, Sheep, Ducks, High Score Jr. Handler and High Score Novice Handler. Class placement ribbons 1<sup>st</sup>-4<sup>th</sup> and Q ribbons. Overnight dry camping is available at the site. Dogs must be leashed at all times. Please clean up after your dog! **Looking forward to seeing you there!**
